### ***Influencing Cyber Security classroom material for the Computer Science GCSE***

CREST is running a workshop with AQA - an independent education charity and the largest provider of academic qualifications taught in schools and colleges – that aims to draw upon the knowledge and experience of the CREST membership to help develop classroom-based material for teaching cyber security in the new Computer Science GCSE specification.

To kick off the day, AQA will explain their new GCSE specification in terms of both teaching and assessment requirements. CREST members, along with computer science teachers and assessors, will then discuss the type of content and resources that would work best in the teaching of cyber security, as well as what is feasible to produce and how this will be done.
