### **CREST Singapore Chapter established**



In partnership with the Cyber Security Agency of Singapore (CSA) and the Association of Information Security Professionals (AISP), CREST has established a Singapore Chapter to introduce its penetration

testing certifications and accreditations to Singapore. This initiative was developed in collaboration with the Monetary Authority of Singapore (MAS), the Association of Banks in Singapore (ABS) and the Infocomm Development Authority of Singapore (IDA). The CREST Singapore Chapter is the first CREST Chapter in Asia.

Along with the announcement of the new Chapter, the CREST Examination Facility at the Singapore Institute of Technology (SIT) was also officially opened by Mr David Koh, Chief Executive, CSA and a CREST Industry event on 28th July.

### **Industry film**

CREST is working on a film that will describe the industry - with a focus on penetration testing, cyber incident response and cyber threat intelligence - and showcase how UK is leading the way in these areas.
