The Organisation of Threat Intelligence Professionals (OTIPS) group work has now begun in earnest. At an initial meeting involving CBEST accredited threat intelligence companies and other stakeholders, it was agreed that there are significant opportunities to develop the capacity, capability and quality of the threat intelligence sector, as well as a real need for that to occur – not least to support the growing number of intelligence-led penetration testing frameworks globally. Focussed topic groups have been set up and are exploring various aspects of OTIPS. The findings of those groups will be presented back to the core group meeting on 11th June. Following this, there will be further information communicated in Script and to CREST members on the next stages of the development of OTIPS in the near future.
