## Nominations open for the Fellowship Awards

Taking place this year on 14th November, this annual event is to recognise individuals for their achievement or contribution within CREST or the technical information security industry as a whole.

If you would like to nominate someone for consideration by the Awards Panel for a Fellowship, there are three categories of Fellowship and here is the criteria for each:

- Are distinguished by their work and professionalism in support of the development and maintenance of a particular discipline or disciplines over a continual period of five years or more; and/or
- Re-qualifies in their chosen discipline at CREST Certified level on three consecutive full-term recertification intervals. For the avoidance of doubt, this means an individual that has held a Certified level qualification for a continuous period of nine years (or more); and/or
- The CREST Fellowship Award Panel wishes to honour an individual for services rendered to CREST and whose association is of significant and sustained benefit to a CREST discipline.

## New and refreshed suite of Cyber Threat Intelligence examinations available at Pearson Vue

#### **New Practitioner Threat Intelligence Analyst (CPTIA)**

The new CPTIA examination is an entry-level qualification aimed at individuals who are seeking to establish themselves within the Threat Intelligence industry. The CPTIA qualification demonstrates that an individual has a solid understanding of the theory and practice of cyber threat intelligence operations and is competent to undertake operational threat intelligence activities under the supervision of a CCTIM.

The examination consists of a multiple-choice paper. Candidates are required to meet or exceed a two-thirds pass mark in the multiple-choice paper to obtain CREST Practitioner status.

#### **Registered Threat Intelligence Analyst (CRTIA)**

The CRTIA examination is aimed at individuals who are part of a team delivering threat intelligence services. A minimum of two years' experience collecting, analysing and documenting threat intelligence is expected. The CRTIA qualification provides assurance that an individual has reached the appropriate standard as a threat intelligence team member to deliver safe, legal and ethical services with a minimum of supervision. The examination will consist of two components: a multiple-choice paper and a selection of long form questions that require detailed written answers.

#### **Certified Threat Intelligence Manager (CCTIM)**

The CCTIM examination is aimed at individuals who manage engagements to collect, analyse and disseminate threat intelligence to clients and who have previous experience managing a team producing threat intelligence.

The CCTIM qualification provides assurance that an individual has reached the appropriate standard to manage a team delivering these services.

The examination has three components:

- Short-form questions which require single word or short sentence answers
- Long form questions that require detailed written answers
- A written scenario-based element which reflects tasks which a CCTIM is likely to perform on a regular basis

The CCTIM is divided into two parts (TIM1 and TIM2). Part One must be taken before Part Two.

All of these examinations are available at Pearson Vue centres



## CREST and INFOSECURITY EUROPE 2019

CREST had another very successful event at Infosecurity Europe 2019 this year. The CREST stand was always packed, and it was great to see comments on social media talking about how busy the CREST stand always was! There were lots of positive comments about seeing a student at the event on the CREST stand.

We had a lot of people interested in exams and the threat intelligence guide went down well. Six videos were recorded most of which are on the CREST YouTube channel and have been promoted.











## CREST and EC-Council certification equivalency

CREST and cyber security certification body EC-Council have announced mutual equivalency for their professional entry-point technical qualifications. This significant initiative reflects the need to create an industry framework for equivalent technical cyber security qualifications measured against the same criteria to replicate the approach in other professions.

The announcement helps to address the confusion around qualifications, providing clear development credentialed pathways and access to professional careers. This gives the buying community a much better idea of the level of skill, knowledge and competence of the individuals, allowing them to recruit and contract in a more informed and intelligent manner. Both CREST and EC-Council qualifications are recognised globally and have been formally reviewed by governments and regulators.

The direct equivalency relates to the EC-Council Security Analyst (ECSA v10) qualification with the CREST Practitioner Security Analyst (CPSA) qualification. In addition, equivalency can also be granted for the for ECSA (Practical) with the CREST Registered Tester (CRT) certification, provided that the candidate already holds a valid CREST CPSA qualification. The requirement that a Code of Conduct is signed remains an important part of the process ensuring ethical practices within the industry. Re-examination and continuous professional development are required to retain the qualifications to ensure currency.

"This formal agreement with EC-Council reflects the growing demand for skilled and experienced penetration testers and helps to establish a global ecosystem of certified professionals so that companies and organisations anywhere in the world have the confidence and trust in their purchasing and recruitment decisions," said lan Glover, President of CREST.

"This collaboration offers major benefits for current CREST and EC-Council professionals certified via rigorous hands-on exams that are proctored and is a testament of the high-quality exams provided by both organisations. Building professional, well-defined career pathways will encourage more high-quality entrants to the industry, to create a larger pool of certified and trusted professionals. It also presents greater international job opportunities for penetration testers globally," added Jay Bavisi, President of EC-Council Group.
