Prize draw competition rules

CREST International launched its Annual Member Survey 2024 on 21 March 2024.

As part of this, we have launched a Prize Draw. The rules of the draw are set out below.

## Dates

The prize draw starts with the launch date of the survey at 09:00 on Thursday 21 March 2024.

The prize draw closes and ends in line with the survey at 23:59 on Friday 26 April 2024.

Only survey responses received during this period will be considered for the prize draw.

Any responses received after the closing date and time will not be considered for the prize draw but may still be considered as part of the survey response cohort.

## Prizes
